You are required to provide certain information to the court when you file bankruptcy. It is your obligation to obtain information to include in your bankruptcy petition. Attached are forms designed to obtain the necessary debt information.

1. List **ALL** your debts:
 - a. You must list debts that will not be discharged, such as taxes, student loans, and child support.
 - b. You must list debts that you intend to pay such as your home, car, family doctor.
 - c. You must list debts that you cosigned for someone else or that someone else co-signed for you.
 - d. You must list debts owed to friends or family members.
2. Attach additional sheets if you do not have enough space to include all your debts, using the same format.
3. In determining the amount owed each creditor, list the amount on your most current statement or correspondence from the creditor.
4. **Use the correspondence address for the creditor NOT the payment address.** If only one address is on the bill that address is sufficient. Keep all mailings from your creditors, so we can keep up with any changes in the creditors' addresses and prove, if necessary we used the appropriate addresses.
5. List the account number, if any, for each debt.
6. **If you have a judgment against you the judgment with the case number and the original creditor must be listed. Failure to list this could result in a lien against your property surviving the bankruptcy.**

A Discharge of Debts is limited to the creditors who receive notice of your bankruptcy. When you fill out the list of creditors, please note that we can only list the creditors you provide us. You **MUST** list all individual and/or businesses that you owe money to.

To expedite the preparation of your documents, please provide complete information for each creditor and remember that we need to be able to read your writing. Give specific details on what the debt is for, (Example: first mortgage, 2009 Ford F150 XLT, Couch/TV, income taxes, credit card purchases, medical bills, personal loan, etc.).

* A co-signer is someone other than your filing spouse who is obligated to pay the debt if you don't. If you have the same co-signer on more than one debt, you need only provide their complete address once. However, please name the co-signer for each creditor.
